At our Title I Annual Meeting, a PowerPoint is shared with the parents and families regarding information on the standards the child is expected to achieve, what the child is learning, how the children are being evaluated, and how to get in touch with the teacher. We also endeavor to create an "Orientation Video" that reviews much of this information, so that new students/parents who may have missed out on some of the initial meetings are still able to take advantage of the previously conveyed information.
